IMPORTANT REMINDERS

- *Costs to repair damage to neighborhood common fences, as a result of trees located on the property of a Homeowner, are the responsibility of that Homeowner.*
- *The primary purpose of our Ponds is for drainage. There is absolutely no Fishing or Swimming allowed. This is for YOUR safety and that of your children!*
- *Please do not put trash, newspapers or other debris, including any chemicals (oil, transmission fluid, fertilizers, etc.) into the Ponds (or the public drainage system, as these items adversely affect our water supply).*



PROBLEMS WITH BARKING DOGS??

We've received numerous complaints about barking dogs. According to City of B.A. Municipal Codes, an animal that is a "significant disturbance to the peace" (aka BARKING!) can be picked up and impounded, and will not be released to its owner until all fees, plus room and board charges are paid in full. To avoid these costly fees (AND BE A GOOD NEIGHBOR!), you will want to listen for your dog's barking when you are at home, and make certain your dog is inside when you are away from home.

To report a barking dog, contact the Animal Shelter at 918-259-8311 during business hours. It is helpful to keep a log with the dates/ times the dog has been barking to provide to the Animal Control Officer. After hours, call the Broken Arrow Police Communications Center at 918-451-8200.

Also, per City Codes, pets must be "securely leashed" when off your premises. BE A GOOD NEIGHBOR, please pick up after your dogs!
